PARLIAMENTARY ELECTIONS ACT (CHAPTER 218)

PARLIAMENTARY ELECTIONS ACT (AMENDMENT OF FIRST SCHEDULE) REGULATIONS 2001

In exercise of the powers conferred by sections 102 and 107 of the Parliamentary Elections Act, the Prime Minister hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Parliamentary Elections Act (Amendment of First Schedule) Regulations 2001 and shall come into operation on 17th October 2001.

Amendment of First Schedule

2. The First Schedule to the Parliamentary Elections Act is amended by deleting Forms 1, 9, 9A, 12, 19, 20 and 21 and substituting the following Forms, respectively:

WHEREAS section 24 (1) of the Parliamentary Elections Act provides that for the purposes of every general election of Members of Parliament, and for the purposes of the election of Members to supply vacancies caused by death, resignation or otherwise, the President shall issue writs under the public seal, addressed to the Returning Officer:
