# PARLIAMENTARY ELECTIONS ACT (CHAPTER 218)

### PARLIAMENTARY ELECTIONS ACT (AMENDMENT OF FIRST SCHEDULE) REGULATIONS 2011

In exercise of the powers conferred by sections 102 and 107 of the Parliamentary Elections Act, the Prime Minister hereby makes the following Regulations:

#### Citation and commencement

1. These Regulations may be cited as the Parliamentary Elections Act (Amendment of First Schedule) Regulations 2011 and shall come into operation on 14th March 2011.

#### **Amendment of First Schedule**

- **2.** The First Schedule to the Parliamentary Elections Act is amended
  - (a) by inserting, immediately after the words "in Singapore dollars" in the notes under Section A in Form 19, the words "and inclusive of GST (if any)";
  - (b) by inserting, immediately after the words "in Singapore dollars" in the notes under Section B in Form 19, the words "and inclusive of GST (if any)";
  - (c) by inserting, immediately after Form 19, the following Form:
