**PRESIDENTIAL ELECTIONS  
(FORMS AND FEES) (AMENDMENT)  
REGULATIONS 2011**

In exercise of the powers conferred by section 81 of the Presidential Elections Act, the Prime Minister hereby makes the following Regulations:

**Citation and commencement**

1. These Regulations may be cited as the Presidential Elections (Forms and Fees) (Amendment) Regulations 2011 and shall come into operation on 2nd August 2011.

**Amendment of Schedule**

2. The Schedule to the Presidential Elections (Forms and Fees) Regulations (Rg 1) is amended —

(a) by deleting Form P7 and substituting the following Form:
