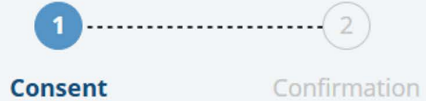
Before Nomination Day, the prohibition will apply to content depicting individuals who identify themselves as prospective candidates. This refers to individuals who have:
