- (iv) A non-citizen of Singapore

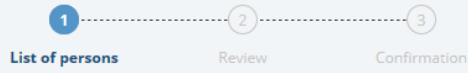

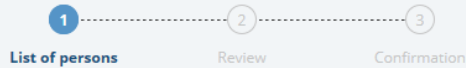

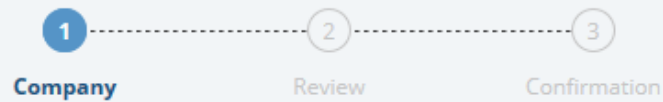

Who must be issued the written authority to conduct election activity?

Subject to section 83 of the Parliamentary Elections Act, anyone conducting election activity must be in possession of a written authority signed by the candidate or his election agent.

Workers who are **Singapore Permanent Residents or work pass holders carrying out manual work** under a contract for services between the candidate (or his election agent) and an authorised person **do not need a written authority to conduct election activity.**
