EXHIBITION OF THE REGISTERS OF ELECTORS

The revised Registers of Electors for the 23 Constituencies (14 Group Representation Constituencies and 9 Single Member Constituencies) are currently open for public inspection at 105 Community Centres/Clubs and the 8 Singapore diplomatic Missions in Canberra, London, Beijing, Tokyo, Washington, Hong Kong, Shanghai and San Francisco. Members of the public can also visit the Singapore Elections website (www.elections.gov.sg) or the eCitizen Portal (www.ecitizen.gov.sg) to check their names in the Registers of Electors.

2 Singapore citizens who have yet to check the Registers of Electors are urged to do so by 11 October 2004.

3 Overseas Singaporeans who wish to apply for registration to vote at any of the 8 above-mentioned Missions can find out more about overseas voting from the Singapore Elections website, where they can also download the form for "Application to be Overseas Elector". The duly completed and signed application forms must be submitted to Elections Department or any of the said Missions by 18 October 2004, either in person or by registered post.
